Rental space: approximately 10' x 10' will be assigned on a first-come, first-served basis. If you need more than one 10' x 10' space, please contact us, before July 31st. You may supply your own table(s) and chair(s) or rent them, from SASI. If you want to rent one or more tables or chairs, in addition to your space, please call us, to reserve them, before July 31st. If you need electric power, you must supply your own and inform us, prior to July 31st. If you have any other special requirements, please contact us, before July 31st. Applicant agrees to abide by all of the above conditions.

SASI will be the sole determinant of table locations. 8 foot tables are \$15.00 each; chairs are 2 for \$5 [minimum chair rental = 2]. Tables and chairs must be paid for, by July 31st. There will no additional tables or chairs available, for rent, on the day of the event.

Dear Hunting & Fishing Day Expo vendor/exhibitor:

We appreciate your participation, in addition to valuing your efforts and contributions toward the success of the celebration of the 42nd annual National Hunting & Fishing Day Expo. Coincidentally, September 28th, 2013, will mark the 42nd year of *SASI's* sponsorship of this event.

Rules

To provide an orderly event and ensure the safety and enjoyment of everyone involved, especially our guests, we insist that the following rules be scrupulously observed:

1. The NHFD Chairman of *SASI*, will be the final arbiter of table assignments, parking spots and all other aspects of the conduct of the expo.
2. Vendors and exhibitors must be constantly aware of the hazards presented by the large number of normally excitable, curious children who will be present and, therefore, maintain constant vigilance to ensure their safety, plus that of all others present.
3. Vendor's and exhibitor's vehicles must be parked in their assigned spots, as close together as practical.
4. Vehicles operated on the property must be operated safely, at ***no greater than 5 MPH*** and must be preceded by a guide, on foot, to guard against accident. Special cognizance must be taken of the many children present, to ensure their safety.
5. Vendors and exhibitors who have *any form* of wildlife or domestic animals shall be strictly accountable for their safe and humane treatment, at all times and to prevent any unauthorized contact with or handling of same by visitors, especially children, at any time.
6. Violation of any of these rules will, at the sole discretion of *SASI's* NHFD Chairman, result in the expulsion of the violator and the suspension of said violator's privilege to participate in similar future events. No refunds will be made, in any case involving such expulsion(s) or suspension(s).
7. All vendors, exhibitors and other active participants in this event agree:
 - a) by receipt of this communication or
 - b) by purchase of rental space or
 - c) by purchase of other facilities or
 - d) through receipt of free admission to participate in this event,to abide by all conditions and restrictions set forth herein.
